### Penalty:

In case of failure of completion of work within given time, a penalty @ 0.1% of total contract amount, for each day of delay will be imposed.

## Mode of Payment:

All payments shall be made strictly against the actual measurement/ quantum of work done at site duly verified by Bank's representative. Following mode of payment shall be adopted:

## Payment Schedule:

- i. No advance payment will be made.
- ii. First interim Payment i.e 30% will be made on receiving original invoice from the contractor and confirmation of 35% completion of work by respective Zonal Chief / Regional Controller / Bank Representative of the bank.
- iii. Second interim payment i.e 30% will be made on receiving original invoice from the contractor and confirmation of 70% completion of work by respective Zonal Chief/Regional Controller / Bank Representative of the bank.
- iv. Final 35% payment will be release to contractor on receipt of final invoice from the contractor and as per actual measurements by the Bank Representative during his physical inspection of the completed project.
- v. 05% of the total project amount will be retained by the Bank as "Retention Money" which will be released after 180 days of completion of the project along with receipt of satisfactory letter from the concerned branch. However if vender agreed, their 2% performance security deposited earlier, may be adjusted in retained amount On completion of said period a final inspection will be carried out and the retention amount will only be released addressing of observation and due verification from concerned Branch Manager.
