- iii. Warranty of 01 year of all the purchased items should be provided at the time of supply.
- iv. The Purchase/Technical Committee will inspect the items in accordance with supply order and rejected items will be replaced by firm at its own cost.
- v. If found any item refurbished, defective or not conforming to standard/specification given in the supply order items will be rejected at any time and the proceeding initiating against the firm for blacklisting.
- vi. All relevant softwares should be installed.
- vii. Payment will be made through cross cheque to supplier as follow:-
 - 70% payment after the satisfactory delivery of equipments;
 - 30% payment after inspection and product acceptance/certification upon the verification of Technical/Purchase Committee of Azad Kashmir Transport Authority. No advance payment will be made to the supplier.
- viii. All taxes levied by the Govt. of AJK will be deducted from the total value of the invoice as admissible under rules.
- ix. The equipment should be delivered at central office of Azad Kashmir Transport Authority, Muzaffarabad.
- x. Transportation charges will be borne by the supplier.
- xi. Supplier will be responsible for any loss, theft, damage until delivery is received by administration of Azad Kashmir Transport Authority.
- xii. In case of failure to supply the items as per specification, supply order shall be cancelled and CDR shall be confiscated.
