INVITATION FOR BIDS


1. The Executive Engineer PWD Buildings Division Bagh ("The Employer") has received funds through Development Budget of Education Sector for execution of the following project through contract for the Year 2018-19.

Bidding is open to all eligible Bidders.

2. The Employer invites sealed bids, under single stage-one envelope bidding procedure, from eligible firms or persons licensed by the Pakistan Engineering Council in the category **C-6 and above with Specialization Code CE-09 & CE-10** duly endorsed by the Employer. A foreign bidder is entitled to bid only in a joint venture with a Pakistani constructor in accordance with the relevant provisions of PEC bye-laws.
3. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from **Office of Executive Engineer PWD Building Division, Bagh , AJ&K Ph. No. 05823-920073**
4. A complete set of Bidding Documents may be purchased by an interested/eligible bidder from above office on or before **April 22, 2019** during office hours, upon payment of a non-refundable fee of Rs. 3000/- .
5. At the time of purchase of Bidding Documents eligible Bidder has to submit the following:
- An application on the letter head of the firm addressed to the **Executive Engineer PWD Building Division Bagh**
 - Payment of a non refundable fee as mentioned at S.4 above.
 - Declaration/affidavit that the firm/constructor is not black listed by any of the departments/ ministries.
 - List of completed works with cost, allotted to firm along with copy of work order and completion certificates.
 - List of ongoing works along with copy of work order, performance certificate etc.
6. Tender Documents will be issued only to constructor (s)/ Firm (s) or their authorized representatives (s) who will show original power of attorney along with original Authority Letter.
7. Bidding will be done on "AJKCSR 2nd Semi-annual (Jan. to Jun. 2019) 2018-19 (District Bagh) above/below and quote his rates for Non CSR item. Contractor has to write his bid in BOQ in figures up to 2 decimal (only two digits after decimal will be considered).
8. Sealed Bid along with a Bid Security in the amount as mentioned in Para 1 above by a Scheduled Bank in Pakistan having branches in AJ&K in favour of **undersigned** must be submitted to **Office of Executive Engineer PWD Building Division Bagh, AJ&K** on **April 23, 2019** at or before 1100 hours. Bids will be opened at 1200 hours on the same day in the presence of bidders or their authorized representatives who choose to attend at the same address.

- f. Bidders quoting rates less than 10% below than Engineer's Estimate will have to provide additional bid security of the value equal to the amount less than the Engineer's estimate with the bid. Failure to do so will result in non-responsiveness, and also Bidder quoting rates less the 15% below the Engineer's Estimate will be declared as non-responsiveness.
9. Only one Tender will be issued to a contractor/firm.
10. All bidders must fill in check list before submission of bid in their own interest as per section G of Instructions to Bidders which is a mandatory requirement.
