INVITATION FOR BIDS

(Under Single Stage—Two Envelope Procedure)


1. The **Executive Engineer PP&H Buildings Division Muzaffarabad** invites tenders for following approved works on Single Stage Two-Envelope basis. Bidding is open to all eligible bidders/firms as per following details/schedule:

Bidding is open to all eligible Bidders.

2. The Executive Engineer Buildings Division Muzaffarabad on behalf of the Employer invites sealed bids under AJK PPRA Rules 36(b) Single Stage-Two Envelope bidding procedure from the eligible firms/contractors/persons licensed by the Pakistan Engineering Council in the category **C-4 and above with Specialization Code CE-10** for the above-mentioned work and should be duly endorsed by the Office of Chief Engineer Buildings/PHE GoAJK having validity for FY 2018-19. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture. Without such approval, bidding document will not be issued.
3. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of the Employer, at **Office of Executive Engineer PP&H Buildings Division, Block-I District Headquarter Complex Muzaffarabad AJK Ph. No. 05822-920133.**
4. A complete set of Bidding Documents could be purchased by an interested bidder on submission of the following on or before **May 02, 2019** during the office hours;
- a) An application on the letter head of the firm addressed to the **Executive Engineer PWD Building Division Muzaffarabad**
- b) Payment of a non-refundable tender fee of Rs. 6000/-.
5. Bidding documents will be issued only to Contractor(s)/Firm(s) or their representative(s) who will submit original power of attorney along with original authority letter on stamp paper of Rs. 100 with each page attested by the Oath Commissioner.
6. Bidding will be done on "AJKCSR 2nd Semi-annual (Jan. to Jun. 2019) FY 2018-19, District Muzaffarabad, above/below" basis. Contractor has to write his bid in tender form both in words and in digits and only two digits after decimal will be considered.

8. A Pre-Bid Meeting will be held in the **Office of Superintending Engineer PP&H Buildings Circle Block-H, DHQ Complex, Muzaffarabad (Chairman Bid Opening/Evaluation Committee) on April 25, 2019 at 1100 Hrs.**
9. Only eligible Firms/Bidders, with the following qualification, can participate in the bidding process:
 - a) has completed at least one (01) contract of similar nature Retrofitting work, with at least value of PKR 60.00 million during the last five (5) years.
 - b) has an average annual turnover of minimum PKR. 50.00 million, during the last three (03) years.
10. All bids (Technical & Financial) along with a Bid Security in the amount as mentioned in Para 1 above in a freely convertible currency in the format of bank guarantee on bid security form or in the form of deposit at call or from a foreign bank duly counter guaranteed by a Scheduled Bank in Pakistan in favor of **undersigned** must be delivered to **Office of Executive Engineer PP&H Buildings Division Muzaffarabad, Block-I District Headquarter Complex Muzaffarabad AJK** at or before **11:00 AM, on May 03, 2019**. Technical Bids will be opened at **11:30 AM** on the same day, in the presence of Bidders or their representatives who choose to attend at the same address. Bids received through Postal Services will also be entertained. After scrutiny and evaluation of the Technical bids, the Financial Bids of only qualified firms/bidders will be opened for which a separate date will be fixed and will be intimated to all qualified firms/bidders in writing. Financial bids of unsuccessful bidders will be returned un-opened.
11. In case the bidders quoted their rates equal to 10% or more than 10% below the Engineering Estimate, they shall have to provide additional bid security along with their bid in the shape of CDR or Bank Guarantee from any scheduled bank in Pakistan having its branches in Azad Kashmir, equal to the amount of difference between the estimated and bid costs. Failure to do so will result in non-responsiveness.
12. All bidders must fill in check list before submission of their bid in their own interest as per section "G" of Instructions to Bidders (I.B) which is a mandatory requirement.
13. Any bid prepared and submitted in contrary to sections C&D respectively of Bidding Documents, as mentioned in "Instruction to Bidders" shall be declared as non-responsive.
14. The employer reserves the rights to reject all of the bids or any bid under the Clause 32 of AJK PPRA Rules.
