1-	The Executive Engineer Development Authority Muzaffarabad on behalf of the Employer , invites sealed bids under AJK PPRA Rules 36 ( a) Single stage – one Envelope procedure from eligible firms or contractors licensed by the Pakistan Engineering Council (PEC) and in appropriate category with field of specialization as mentioned in column No 4&5for the above work(s).
2-	The bidder are required to submit their bids in accordance with the clause 29 of the AJK PPRA Rules.
3-	A complete set of Bidding Documents may be purchased by an interested bidders on submission of a written application along with 2% CDR issued by a scheduled Bank of Pakistan having its branches in Azad Kashmir in favor of the Executive Engineer DAM as earnest money mentioned in column No 8.Open CDR,s will not be accepted and upon payment of a non- refundable tender fee as mentioned in Colum No 6 on or before 17-06-2019during the office hours. The application must be accompanied by a declaration / affidavit that he or its firm is not black listed by any of the departments / ministries and it must also state the name of the works with cost, if any , allotted to him which are still under execution . Bidding documents shall not be issued without this declaration/ affidavit.
4-	Tender Documents will be issued only to contractor ( s) / Firm( s) or their authorized representative (s) who will show original power of attorney along with original authority letter on stamp paper of Rs,100/=
5-	Interested bidders desirous to bid as joint Venture must get prior approval of the employer for bidding as joint venture.Without such approval bidding documents will not be issued.
6-	The bidder shall quote rates in “ Percentage above/ below on the basis of prevailing AJK-CSR and write his rates in figures, limiting to two figures only after decimal point ( any figure beyond two figure after decimal point shall not be


	considered). The condition of two figure after decimal point will also apply in case of quoted rates,
7-	All CDRs except successful bidder will be released after the verification form bank and as per procedure laid down in the bidding documents.
8-	In Case the amount of bid offered is less than 10%, the bidder shall provide additional performance security with the bid in shape of CDR issued by a Scheduled Bank of Pakistan having its branches in Azad Kashmir, equal to an amount of difference between the Estimated and the Bid cost. Failure to provide the said additional performance security with the bid, the bid shall be considered as non responsive and hence rejected.
9-	Bid must be delivered at the office of under – signed on or before 18-6-2019 at 11:30 A.M which will be opened on the same day at 12.00 P.M in the presence of bidder(s) or their representative (s) who choose to attend. Conditional, incomplete and bids filled with lead pencil shall not be accepted.
10-	The employer reserves the rights of reject all the bids or any bid under the clause 32 of AJK PPRA Rules.
11	Any Clarification / information needs by the bidder regarding the above bids to be sought out 5 days before the closing of date.
