- The Executive Engineer PWD Buildings Division Sudhnoti (Pallandri) on behalf of employer's invites sealed bids, under **Single Stage Single Envelope** Bidding Procedure, from eligible firms or Constructor licenced by the Pakistan Engineering Council (PEC) for the year 2019-20 and duly endorsed by the Office of the Chief Engineer Building/PHE North Muzaffarabad Azad Jammu & Kashmir in the appropriate category with field of specialization as mentioned in column No. 4 &5 for the above work. Any information / further detail can be obtained from the office of the undersigned.
- For the above work, only eligible bidders with the following qualification should participate in the bidding process, viz
 - Has completed at least one contract of similar nature of work with a value of PKR 17.674 million during the last 3 years.
 - All other term/ conditions mentioned in bidding document shall also be fulfilled.
- A complete set of Bidding Documents may be purchase by an eligible bidder for the above on submission of a written application to the Executive Engineer PWD Buildings Division Sudhnoti along with CDR as mentioned in column No.8 issued by schedule Bank of Pakistan, having its branch in Azad Jammu & Kashmir in favor of the Executive Engineer PWD Buildings Division Sudhnoti and a upon payment of non refundable tender fee, as mentioned in column No. 6 on or before **25-09-2019** during the office hour
- The application must be accompanied by a declaration /Affidavit that he or its firm is not blacklisted by any department of AJK / Pakistan and is not involved in any litigation with any Government Department. Bidding documents will not be issued without this declaration.
- Tender documents will issued only to the constructor's/Firm's or their authorized representatives who will show original power of attorney along with original authority letter
- The bidders are required to submit their bid on **11.00 AM on 26-09-2019**, bid will be open by the bid opening committee at **12:00 hrs** on the same day in office of Executive Engineer PWD Building/PHE Division Pallandri, Suhnoti, in the presence of bidders of their representatives who choose to attend conditional. Incomplete and bid filler with led pencil will not be acceptable.
- The bidder should quote his rate in percentage above/below on the bases of "**AJKCSR 1st Semi-annual (July to December) 2019-20, on Schedule Items and non-schedule items rates must be quoted by contractor/ Firm.** Contractor has to write his rates in figures, limiting upto two figures only after decimal point (any figure behind two figures after decimal point shall not be considered) the condition of two figures after decimal point will also applied in case of quoted rates.
- In case the amount of bid offered is less than the estimated cost by equal or more than 10% the bidder shall provide with the bid additional performance security in the shape of CDR issued by any schedule bank of Pakistan having its branch in Azad Jammu & Kashmir, equal to the amount of difference between the

- estimated cost and the bid cost. Failure to provide the said additional performance security with the bid, the bid shall be consider non responsive and rejected.
9. All CDR's except successful bidders will be released after the verification from their concern bank branch and as per procedure laid down in the bidding documents.
