INVITATION FOR BIDS

(Single Stage Single Envelop Procedure)

The Government of AJ&K (**The Employer**) has allocated funds through Normal Budget for the Year 2019-20 towards the cost of following Works. It is intended that part of the proceeding of the funds will be applied to eligible payment under the contracts for the following works:

Bidding is open to all eligible Bidders:-

1. The employer invites sealed bids, from eligible firms or persons licenced by the Pakistan Engineering Council (PEC) in appropriate category for the above mentioned Works and duly endorsed with the Employer having validity up to 30th June 2020. (If the case is under process for renewal with PEC he has to submit documentary proof of it).
2. Bidder may obtain further information/detail inspect & acquire the bidding documents from the office of the Executive Engineer PWD Buildings Division Sudhnoti AJ&K during office hours.
3. A complete set of Bidding Documents may be purchased on the payment of Tender fee (as mentioned in column # 6) till 02-10-2019 during office hours, by an interested bidder / firm on submission of a written application to the above office along with the required documents from the eligible firms or persons, upon payment of a non-refundable tender fee furnishing of Bid Security (as mentioned in column # 7) from any schedule bank of Pakistan who has its branches in AJ&K.
4. The application for bid must be accompanied by a declaration /Affidavit that he or his firm is not blacklisted by any department of AJ&K / Pakistan and is not involved in any litigation with any Government Department. Bidding documents will not be issued without this declaration.
5. All Bids must be delivered to Office of the Executive Engineer Buildings Division Sudhnoti AJ&K at or before 12:00 hours on 03-10-2019, the bids will be opened at 12:30 hours on same day, in the presence of bidders/ representatives who choose to attend at the same address.
6. Bidding will be done on “**AJK CSR 1st Semi-annual (July to December) 2019-20 District Sudhnoti**, above / below/ at Par basis. Contractor has to write his bid in tender form both in words and figures upto two decimal (only two digits after decimal will be considered). The condition of two digits after decimal will also apply in the case of quoted rates.
7. If the difference between Bid price & Engineering Cost Estimate is below then 10%, the firm will have to provide additional bid security along with their bid in the shape of CDR or Bank Guarantee from any scheduled bank of Pakistan / AJ&K. Failure to do so will result in non-responsive.
8. All CDR's except successful bidders will be released after the verification from their concern bank branch and as per procedure laid down in the bidding documents.
9. The competent Authority in accordance with PPRA Rule-33 reserves the right to accept or reject any one or all Bids.
