TENDER NOTICE

The Employer, "Directorate of Sericulture GoAJ&K", invites sealed bids under AJ&K PPRA rules from eligible Firms / Companies, Manufacturers / Authorized Dealers / Suppliers duly registered with Tax department and Registrar of Companies / Firms of AJ&K for the following works:-

- A) Purchase of Silkworm rearing appliances & equipment, chemicals and office equipment, etc. under an approved Development Scheme **"Repairing of Old Building and Construction of Rearing Hall in South Districts of AJ&K (Kotli, Mirpur & Bhimber)"** on FOR basis (at Samahni District Bhimber).
- B) Purchase of Silkworm rearing appliances & equipment, chemicals, office equipment and Furniture etc. under an approved Development Scheme **"Development of Sericulture Infrastructure (R&D) in AJ&K (Phase- II)"** on FOR basis (at Sawen Kucha, District Jhelum Valley and Nomanpura District Bagh Azad Kashmir).
 - (i) A complete set of detailed documents of above work may be obtained by interested / eligible bidders on submission of a written application with Non-Refundable fee, amounting to Rs. 1000/- and proof of eligibility.
 - (ii) Bidders may acquire Bidding Documents / detailed specifications of above mentioned work(s) from the Office of the Employer, during office hours, situated with Custodian Building, behind Gillani Petrol Pump, opposite Old Secretariat, Muzaffarabad AJ&K (Ph. # 05822-920818).
 - (iii) Single stage- single envelope "AJK PPRA Rules" shall be opted for this procurement.
 - (iv) All bids must be accompanied with a Call Deposit Receipt @ 2% of quoted bid price, as a Bid Security and must also be delivered to Office of the Director Sericulture, before 11:00 hours, on **06-02-2020**.
 - (v) Bids will be opened at 11:30 hours on the same day in the presence of bidders or their representatives, who may choose to attend, at the same address.
 - (vi) The employer reserves the right to accept or reject all or any of the bids in accordance with AJKPPRA Rules 2017.
 - (vii) The employer reserves the rights to increase, decrease or eliminate any item(s) from the list offered for bidders as per PPRA Rule #42(c) (4).
 - (viii) The successful bidder shall be bound to furnish 10% Performance Security in the shape of Bank Draft, in favor of the Employer, before issuance of supply order.
 - (ix) The Bill against procured items shall be paid to the successful bidder, after ensuring complete / safe supply of the work as per Supply Order issued by the Employer.
 - (x) All taxes / charges from payable amount to successful bidder will be deducted according to the prevailing Laws of AJ&K Government.
