1-	The Executive Engineer Development Authority Muzaffarabad on behalf of the Employer, invites sealed bids under AJK PPRA Rules 36 (a) Single stage – one Envelope procedure from eligible firms or contractors licensed by the Pakistan Engineering Council (PEC) having validity for FY 2019-20 and in appropriate category with field of specialization as mentioned in column No 4&5 for the above work(s).
2-	A complete set of Bidding Documents may be purchased by an interested bidders on submission of a written application and upon payment of a non- refundable tender fee as mentioned in Colum No 6 on or before 07-02-2020 during the office hours. The application must be accompanied by a declaration / affidavit that he or its firm is not black listed by any of the departments / ministries and it must also state the name of the works with cost, if any works, allotted to him which are still under execution. Bidding documents shall not be issued without this declaration/ affidavit.
3-	Tender Documents will be issued only to contractor (s) / Firm (s) or their authorized representative (s) who will show original power of attorney along with original authority letter on stamp paper of Rs,100/= with each page attested by the Oath commissioner.
4-	All interested bidders must bring their original PEC registrations at the stage of Purchasing bid Documents.
5-	In case the bidders quoted their rates equal to 10%, or more than 10% below than Engineering Estimate, will have to provide additional bid security along with their bid in the shape of CDR from any schedule bank of Pakistan /AJK equal to the amount of difference between the estimate and bid costs. Failure to do so will result in non- responsiveness
6-	Bid must be delivered at the office of under – signed on or before 08-02-2020 at 11:30 A.M which will be opened on the same day at 12.00 P.M in the presence of bidder(s) or their representative (s) who choose to attend. Conditional, incomplete and bids filled with lead pencil shall not be accepted. Bids received through postal Services will also be entertained.
7-	Each bidder shall sign each page of bid documents especially form of bid, failure to do so shall result in Non- responsiveness. Besides each bidder will have to submit two (02) copies of his bid in addition to original bid.
