The bidding procedure will be according to AJK Public Procurement Rules PPR 2017 Under "Single Stage, Two Envelops" the bids shall be submitted by the interested firms in Two Separate envelops marked as "Technical Proposal" and "Financial Proposal" in legible and bold letters. The Technical proposals shall be opened on the day of bids opening and financial proposals shall be kept sealed in custody till final evaluation of the technical proposals. The financial proposal of only those firms, who declared as technically qualified/responsive, shall be opened by the DPC on the notified date and time, in the presence of the representatives of the qualified/Responsive firms.
2. Bid must be accompanied by the acceptable CDR/bank draft not less than 2% of the bid value drawn on any scheduled bank, AJK in Favor of **Manager Forest Seed Centre Ghari Dupatta Muzaffarabad AJK.**
3. The bidders are requested to give their best and final prices *keeping in view of market rates* as no negotiations are expected.
4. Taxes will be deducted as per applicable government rules. NTN and Sales Tax registration certificate must be provided.
5. Bids will be evaluated keeping in view the section 36(b) AJK- PPRA rules 2017.
