2. The bidders must be registered with Local Govt. Board AJ&K before the purchasing of bid documents.
3. All interested bidders must bring their original PEC registration and CDR @3% of bid price at the time of bid opening. Failure to do so will result in non-responsiveness.
4. Bidding is open to all eligible Bidders which may obtain further information, inspect and acquire the Bidding Documents from the Office Municipal Corporation Muzaffarabad, Upper Addah Muzaffarabad (Ph #. 05822-920839)
5. A complete set of Bidding Documents may be purchased till February, 11,2020 at 1200 hours by an interested bidder on submission of a written application and upon payment of a non-refundable fee of Rs. 3000/- from the **Office of the undersigned**.
6. Bids will be issued only to eligible bidders or their representatives upon furnishing of application along with power of attorney/ Authority Letter from the bidder.
7. Bidding documents will be issued only to Contractor (s) / Firms (s) or their representative (s) having licensed by the Pakistan Engineering Council in the category C-6 and above mentioned work and should be duly enclosed by the Office of the Project Director Integrated Solid Waste Management and Recycling Capital City Muzaffarabad (MCM) having validity for FY 2019-20 who will submit original power of attorney along with original authority letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
8. All bids must be delivered to the Office of the Project Director Integrated Solid Waste management and Recycling Capital City Muzaffarabad., (MCM) Upper Addah Muzaffarabad JK at or before 11:30 AM, on February 12,2020. The Bids will be opened at 12:00 hours on same day, in the presence of bidder's representatives who choose to attend at the same address. Only the responsive bids will be considered. Bids received through Postal Services will also be entertained.
9. In case the bidders quoted their rates equal to 10% or more than 10% below than Engineering Estimate, will have to provide additional bid security along with their bid in the shape of CDR of Bank Guarantee from any scheduled Bank of Pakistan / AJK equal to the amount of difference between the estimate and bid costs. Failure to do so will result in non-responsiveness.
10. Each bidder shall sign each page of bid documents especially form of Bid, Failure to do so shall result in non-responsiveness. Besides, each bidder will have to submit two (02) copies of his bid in addition to original bid.
