



## INVITATION FOR BIDS

Department of Animal Husbandry Azad Government of the State of Jammu and Kashmir has received budget from Government of Pakistan under “**Prime Minister Initiative for Backyard Poultry**” therefore intends procurement of Poultry Feed and Day Old Chick from well reputed income tax registered companies, as enclosed subject to following terms and conditions:

1. Bidding shall be conducted through “**Open Competitive Bidding**” in pursuant to “**Single Stage-Two envelope**” Procedure specified in the AJ&K PPRA Rules, 2017, 6 (36),
2. Sealed Bids must be delivered to above office at given mailing address/ location on or before **12:30 AM on 17<sup>th</sup> February, 2020.**
3. The successful bidder will have to provide a Bid Security @ **2% of Bid value** in the form of CDR from a Scheduled Bank of Pakistan in favor of **DDO Director Livestock Extension Research & Development.**
4. Bids will be opened in the presence of bidders or their representatives who choose to attend (along with Authority Letter) at **1:00 AM** in the Committee Room, Directorate of Livestock Extension Research & Development. , on the same date.
5. The bidders are required to submit their best and final prices matching to the “**Principle of Value for Money**” meaning Quality Products.
6. Taxes will be deducted as per applicable under AJ&K Tax Laws and Government rules from amount billed for.
7. Specification of items with bidding form annexed herewith the advertisement notice for further classifications meant for Bid submissions or best value/price quotations.
8. Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation” and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
9. Departmental Purchase Committee reserves the right to accept or reject any bid under Rule 33 of AJ&K PPRA Rules, 2017.
10. **Evaluation Report / Award of Contract** shall also be displayed at AJK PPRA website.
11. Successful Bidder shall have to supply Poultry Feed (50 Kg packing) with certificate of feed formula and Day Old Chicks with certificate of Marek’s disease vaccinated as per specification in all district of AJK within 2 weeks after issuance of supply order on FOR basis.

The successful bidder will have to complete supply under the following terms and conditions;

1. **Proceedings:** Supply of the material should commence immediately after receiving supply order
2. **Quality of Material:** The material to be supplied must comply with the recognized stat of the art and generally accepted rules of technology. They must be of excellent quality. In case of supply of Marek’s disease vaccinated Day Old chick, the supplier will contact before delivery and one representative of Livestock Department will personally insure the vaccination at the time of hatch.
3. **Delivery Charges:** Delivery Charges will be included in quoted price.
4. **Miscellaneous Charges:** No hidden charges involved.
5. **Tex Deduction:** All the taxes as per government rules (AJK) will be detected from the whole amount of bill.
6. **Payment Schedule:** Payment will be made by cross check in favor supplier after successfully delivery report submission and clearance of bills from Accountant General.
7. **Delivery Address:** The supplier will have to supply the material in all district of AJK and delivery address will be provided where supply required.
8. **Jurisdiction:** The place of jurisdiction will be Director General Office Muzaffarabad in the event of any dispute arising between Buyer and Supplier:
