Sealed bids are invited for for Repair/dismantling of CT scan PHILIPS Beilliance 16 slice which will be received up to 17.02.2020 at 11:00a.m in the office chamber of the Secretary Health, GoAJK Block No. 10, New Secretariat, Chattar, Muzaffarabad and will be opened on the same day at 11:30p.m in the presence of Bidders or their Authorized Representatives who choose to attend the meeting of bid opening.

S.# Description

a. SKBZ/CMH Muzaffarabad (Dismantling Packing and Transportation)

- Dismantling of CT scan PHILIPS Brilliance 16 slice from SKBZ/CMH Muzaffarabad and safe Transport to SKBZ/CMH Rawalakot.

b. SKBZ/CMH Rawalakot Repair and operationalization)

- Replace of faulty Parts with serviceable parts of CT scan PHILIPS Brilliance 16 slice dismantled from SKBZ/CMH Muzaffarabad
- Service key Generation Charges
- License Software for at least one Year
- Calibrations/service charges to make the CT scan fully operational

c. Service/ maintenance agreement for three years will be submitted separately in a sealed envelope

1. Bidding shall be conducted through Single Stage - Two Envelopes bidding procedure of AJK Public Procurement Rules, 2017. The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.

3. Bid Security (CDR) @ 3% of total bid value of quoted items in the name of Director General Health AJK Muzaffarabad must be accompanied with the financial bid and also photocopy of CDR must be attached with technical bid (amount not shown). Cheques shall not be accepted.

4. Bids shall remain valid for 120 days.

5. A complete set of Bidding document duly signed/stamp by competent person of the bidder

6. All bidders shall furnish an affidavit /certificate that they are neither black listed nor in conflict with government anywhere in territory of the State of Azad Jammu & Kashmir, Federally administrated areas and provinces of Islamic Republic of Pakistan.

7. Evaluation report and Award of contract shall also be displayed on PPRA web site.

8. All taxes / duties levied by GoAJK will be charged from the bills under admissible rules.

9. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form are mandatory.

10. Soft copy of quoted specification must be attached with "TECHNICAL PROPOSAL" in the shape of CD or Flash Drive.
