Bids / Application complete in all respect should reach on or before 25 February 2020, at 10:00 AM in the office of the **Director MNCH Program, Go.AJK**. Technical Proposal received will be evaluated by the Department Selection Committee (DSC) and Qualified / Responsive bidders will be shortlisted which later will be called for the opening of the financial bids. All taxes will be applicable as per AJK PPRA Rules.

General Terms & Conditions:-

1. Consultancy firm / individual with at least 5 years of relevant experience at state / provincial, national/international level and required qualifications are eligible to apply.
2. Consultancy firm/individuals should have the specific experience of policy making and preferably working with public and private sector.
3. The bidding procedure will be **"Single Stage-Two Envelopes"** the bids shall be submitted by the interested firms / individuals in two separate envelopes marked as **"Technical Proposal "**and **"Financial Proposal"** in legibly and bold letter. The Technical proposal shall be opened on the day of the bid opening and financial proposal shall be kept sealed in the custody till the final evaluation of the technical proposals. The financial proposal of only those firm/individuals, whom declared as technically qualified/ responsive, shall be opened by the DSC on the notified date and time, in the presence of the representative of the qualified/responsive firms/individuals.
4. Each Financial Bid must be accompanied by the acceptable CDR/Bank draft not less than 3% of the bid/value drawn on any scheduled bank, AJK in favour of **Director MNCH Program, Go.AJK**.
5. The bids validity period is 90 days from the opening of the bids.
6. Technical and Financial proposals will be evaluated keeping in view the section 36(b) AJK PPRA Rules 2017.
7. Firm/Individual also needs to annex affidavit stating that firm/individual was never black listed.
8. Un-sealed application or those received via fax/email or after due date shall not be accepted.
9. All terms & Conditions mentioned in AJK PPRA Rules 2017 shall be applicable on this Consultancy Procurement.
