- ii. Under AJKPPRA rules "Single Stage Two Envelop Procedure" will be adopted for finalization of the award of the work. Hence, the Bid shall comprise one single envelope containing, separately, financial proposal and technical proposal.
- iii. The Financial Bid comprising of 2% call deposit in favor of the Director General Tourism & Archaeology (refundable) must be submitted without which the offered bid shall stand non responsive.
- iv. The company must have valid registration of Income/ Sales Tax and the relevant documents shall be made part of technical proposal.
- v. The bidder must incorporate affidavit (with the technical proposal) of neither blacklisted by any public organization nor bankrupted by any scheduled commercial banks as well as non-involvement in any litigation.
- vi. The payment will be made after testing and commissioning as per report of the inspection committee (after completion of job as per specifications).
- vii. All prevailing taxes will be deducted from the invoice.
- viii. No transportation Charges will be paid.
- ix. Delivery shall be made at the AJK Tourism Complex, Muzaffarabad.
