The Executive Engineer PWD Highways Division Neelum invites tenders for following approved work on **Single Stage Two-Envelope** basis. Bidding is open to all eligible bidders/firms as per following detail/schedule:


1. **Executive Engineer PWD Highways Division Neelum** on behalf of Employer invites sealed bids under **AJKPPRA Rules 36(b) Single Stage-Two Envelope** Procedure, from eligible firms or contractors licensed by Pakistan Engineering Council (PEC) and duly endorsed by Public Works Department (PWD) AJK in the appropriate category with field of specification as mentioned in column No.5 for above works.
2. The technical qualification criteria are mentioned as below:
 - (a) Firm / Contractor has completed at least one contract of similar nature of work, with the minimum value of work Rs. 510.000 million during the last 5 years.
 - (b) The average annual turnover required for Rs 476.000 million during the last three years.
3. A foreign bidder is entitled to bid only in a joint venture with Pakistani Contractor/Firm in accordance with the relevant provision of PEC by-laws and local interested bidder desirous to bid as Joint Venture must get prior approval of the Employer (**Chief Engineer Highways North**) for the bidding as joint venture without such approval bidding documents will not be issued. .
4. Tender documents will be issued **upto 10-03-2020 during office hours**:
 - (a) On submission of written application to the above mentioned office. The application must be accompanied by a declaration/affidavit that the bidder is not black listed by any of the departments/ministries.
 - (b) Only to contractors / firms or their authorized representatives who will submit original power of attorney along with original authority letter on stamp paper of Rs. 500/- with each page attested by the Oath Commissioner and original ownership papers of Asphalt Plant.
 - (c) Original PEC License must be presented at the time of purchase of bidding documents.
 - (d) The cost of bidding documents shall be charged Rs. 9000/- as tender fee plus prevailing Taxes.
5. Bidding will be done on "AJKCSR 1st Semi-annual (Jul. to Dec. 2019) FY 2019-20, District Neelum, on percentage (above/below) basis. Contractor has to Quote the rates of Bid price in words and in digits and only two digits after decimal will be considered. The condition of two digits after decimal points will also apply in case of Non-Scheduled rates.
6. The CDRs of un-successful bidders shall be released after the approval of bid evaluation report.

In accordance to the notification No. B-12(7)/Works/2004 Dated 10-12-2004 by Govt. AJK, in case the amount of bid offered is less than the estimated cost by 10% or more than 10%, the bidder shall provide with the bid additional bid security in the shape of CDR/Bank Guarantee issued by a Schedule Bank in Pakistan or Bank of AJK, equal to the amount of difference between the Estimated Cost and the Bid Cost. Failure to provide the said additional Bid security with the bid, the bid shall be considered as non-responsive and rejected.

8. A Pre-bid meeting will be held in office of the **Superintending Engineer PWD Highways Circle 1st Floor, Block-H, DHQ Complex Muzaffarabad on 05-03-2020 at 12:00 PM.**
9. The bidders are required to submit their financial and Technical bids (sealed) in separate envelopes, clearly marked as 'Original' and 'Duplicate" both envelopes shall be enclosed together in a single outer envelope, before **12:00 PM on 11-03-2020**, technical bid will be opened by the bid opening & evaluation committee at **12:30 PM** on the same day in **office of the Executive Engineer PWD Highways Division Neelum** in the presence of bidders or their representatives who choose to attend. Conditional, incomplete and bids filled with led pencil will not be acceptable. After evaluation of technical bid the financial bids of only qualified bidders will be opened. Financial bids of technically unsuccessful bidders will be returned un-opened.
10. Any bid prepared and submitted in contrary to section C & D respectively of Bidding Documents, as mentioned in "Instruction to Bidders" shall be declared as non-responsive.
11. The competent authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
