
Invitation for Bids

Sealed bids are invited for procurement of following equipment during the financial year 2019-20, which will be received up to **10.03.2020** at 11:30a.m in the office of Jinnah Dental Hospital Muzaffarabad, GoAJK and will be opened on the same day at 12:30p.m in the presence of Bidders or their Authorized Representatives who choose to attend the meeting of bid opening.

1. Bidding shall be conducted through **Single Stage - Two Envelopes** bidding procedure of **AJK Public Procurement Rules, 2017**. The envelopes shall be marked as **“TECHNICAL PROPOSAL”** and **“FINANCIAL PROPOSAL”** in bold and legible letters. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.
2. For supply of Digital Dental Intra-Oral Imaging System .all manufactures/ Authorized Importers and authorized distributors/dealers can participate.
3. Bid Security (CDR) @ 2% of total bid value in the name of Executive Director Jinnah Dental Hospital Muzaffarabad AJK must be accompanied with the Financial Bid. Cheques shall not be accepted.
4. Bids shall remain valid upto 120 days.

8. All bidders (companies, Firms, Distributors Dealers) are directed to make registration with AJ&K income tax department otherwise, they will be considered as Non Filer in AJ&K.
9. All taxes / duties levied by GoAJK will be charged from the bills under admissible rules.
10. All bids should be submitted in Tape Binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form are mandatory.
