Tender/Bids complete in all respects should reach on or before 10th March, 2020 till 12:00p.m hrs. in the office of the Secretary Relief, Disaster Management & Civil Defence Block No. 10 New Secretariat ,Chatter Muzaffarabad Azad Kashmir, which shall be opened on the same day at 12:30 p.m. by committee in the presence of Bidders or their authorized representatives who opt to attend the meeting.

TERMS & CONDITIONS: -

- 1. The bidding document contains detailed specifications instructions and conditions for those who intend to participate in the bidding process and all Interested manufacturers / firms / importers / bidders / suppliers/ authorized dealers are earnestly advised to read the bidding document before submission of their proposals / Bids which can be obtained the bidding documents for a non-refundable cash payment of RS. 500/- from the office of Director State Disaster Management Authority, Block No. 10 New Secretariat ,Chatter Muzaffarabad Azad Kashmir, on or before 6th March, 2020 during the office hours.
- Black listed Firms/Companies/Suppliers/Distributors/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
- 3. Financial guarantee from insurance companies shall not be accepted.
- Call deposit receipt for an amount equal to 2% of the total offered value in favor of Director SDMA Muzaffarabad Azad Kashmir should accompany every quotation otherwise the offer will not be entertained.
- Bid prices must be quoted on the relevant page of bidding document i.e. price schedule for the material to be offered, duly filled, signed and stamped by authorized representative of bidder, supported by the bid security.
- 6. Pre delivery inspection will be carried out before taking over the ordered items.
- 7. Quoted price of the offered items should include all enforced applicable taxes vogue in AJ&K.
- 8. The successful bidders shall be bound to supply the ordered items within 60 days in respect of equipment, furniture and within 90 days in respect of vehicles from the date of issuance of work order.
- 9. Vehicles shall be brand new, latest model in accordance bidding document specification and shall be delivered at Muzaffarabad (A.K). Bids for vehicles should include split details of ex-factory price, transportation charges and taxes separately.
- 10. Incomplete and conditional offers shall not be entertained.
- 11. Brochures of the quoted items containing Technical Data shall be furnished along with the bids.
- 12. In case of foreign bidders, bid document will be issued/accepted through their approved representatives/agents or distributors in Pakistan holding authority from their Principals for obtaining the documents and participating in bids.
- 13. Foreign bidders and manufacturers of goods for which local bidders quote must possess sufficient experience in performance and marketing. The successful bidders shall be required to submit a

performance bond equal to 10% of the contract price within 10 (Ten) days after being declared successful bidder for award of supply contract.

14. The competent authority reserves the right to accept or reject any quotation in part or full assigning any reason therefore.
