2. A complete set of Bidding Documents may be purchased till March 25, 2020 @ 1500 Hours by an interested bidder on submission of a written application and upon payment of a non-refundable fee from the **office of the undersigned.**
3. Bids will be issued only to eligible bidders or their representatives upon furnishing of application along with power of attorney/Authority Letter from the bidder.
4. The interested bidders will have to submit filer certificate dully issued by Central Excise and Taxation Department at the time of purchase of bid document.



5. Bidding documents will be issued only to Contractor (s) / Firms (s) or their representative (s) who will submit original power of attorney along with original authority letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
6. All bids must be delivered to Office of **The Conservator of Forests Muzaffarabad Circle Bank Road** at or before 11:30 AM, on March 26, 2020. The Bids will be opened at 12:00 PM on same day, in the presence of bidder's representatives who choose to attend at the same address. Only the responsive bids will be considered.
7. Firm/Individual also need to annex an affidavit with bid on judicial paper par Rs 100/- that firm/individual is never been blacklisted by any Government/Semi-Government institution.
8. In case the bidders quoted their rates equal to 10% or more than 10% below than Engineering Estimate, will have to provide additional bid security along with their bid in the shape of CDR or Bank Guarantee from any scheduled Bank of Pakistan/AJK equal to the amount of difference between the estimate and bid costs. Failure to do so will result in non-responsiveness.
9. The competent authority reserve the rights to reject all the bids or any bid under the clause 33 of AJK PPRA rules.
