The interested Consultancy Firm/Companies having relevant expertise/experience are required to submit their Technical & Financial proposals along with complete bio-data of firms including the following details.

- I. Name of firm, Address, Phone, Fax Number, Email Address and website (if any).
 - II. Legal status of registration and latest registration renewal letter.
 - III. Financial status (Bank statement, Balance sheet, Audit report of last three years).
 - IV. Income tax registration certificate and Income Tax certificates of last Five years.
 - V. Core Staff strength and profile of human resources (annex CVs of not more than one page for each individual).
 - VI. Organization's professional experience (list of assignments and clients over the last three years).
 - VII. Total length of professional experience relevant of projects specified including brief detail of already completed and ongoing projects of similar nature (one page summaries of the projects undertaken) and experience of working in similar activity.
 - VIII. Total amount turnover in Pak Rupees for last Five years (in case of consortium disaggregated information for each firm). One year?-2 year ago?-3 year ago?
 - IX. Affidavit on stamp paper duly attested by First Class Magistrate that the firm has neither been black listed nor any contract in the past for not fulfillment of contractual obligations and also firm is not involved in any litigation. The statement referred also to include the certification that the statement is correct and nothing has been kept hidden intentionally.
 - X. Accomplishment list of projects of similar kind of various provinces and AJK.
- The proposal shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal and evaluation to be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
 - Bidders are required to furnish Bid Security (Refundable) in the form of Bank Draft/Pay Order equivalent to 3% of the total bid price in favor of Managing Director Azad Kashmir Small Industries Corporation.
