


## **Invitation for Bids**

Bids are invited for procurement of Insecticides/ Larvicides/Spraying Machinery/RDTs etc. (WHO Approved formulation) received up to **13<sup>th</sup> May 2020** in the office of **Director Health Services (CDC), District Headquarter Complex Old Secretariat, "J" Block, Basement, Room No. 12 Muzaffarabad AJ&K** will be opened on the same day at 12:30 hrs. in the presence of Bidders or their Authorized representatives who attend the meeting of bid opening.

1. Bidding shall be conducted through Single Stage - Two Envelopes bidding procedure of AJK Public Procurement Rules, 2017. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.
2. For supply of Insecticides and Larvicides distributors of products of manufactures of WHO approved formulation can participate in Bidding.
3. Bid Security (CDR) @ 2% of total bid value in the name of Director Health Services (CDC) Muzaffarabad must be accompanied with the financial bid. Cheques shall not be accepted.
4. Bids shall remain valid up to 30-06-2020.
5. A complete set of bidding document including detail specifications, Quantity, Terms & Conditions can be obtained up to **13<sup>th</sup> May 2020** before 10:00 am on submission of written application and upon Payment of Rs.1500/- (Rupees One Thousand Five Hundred) Non refundable, in shape of cash as bidding document fee from the office of Director Health Services (CDC), (Ph # 05822-920010) District Headquarter Complex Old Secretariat, "J" Block, Basement, Room No. 12 Muzaffarabad AJ&K
6. All taxes / duties levied by Govt. AJ&K will be chargeable from the bills under admissible rules.
7. All bids should be submitted in Tape Binding. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form is mandatory.
8. All Bidders shell furnishes and Affidavit/Certificate that they are neither black neither listed nor in conflict with Govt. anywhere in territory of the state of Azad Jammu & Kashmir, Federally administrated areas and provinces of Islamic Republic of Pakistan.
9. In case of non-registration with AJ&K Govt. Tax Department, bidder will be considered as non-filer
