Sealed Tenders under Single Stage-Single Envelope procedure bidding process are hereby invited from all the contractors/firms who are registered with Pakistan Engineering Council (PEC) in the relevant field & appropriate category, in separate sealed envelopes in accordance with PEC guide lines & AJK PPRA rules-2017

The Executive Engineer Public Health Engineering Division Muzaffarabad on behalf of the Employer invites sealed bids from the eligible firms/contractors/persons licensed by the Pakistan Engineering Council in the **C-5 and above with Specialization Code CE-09 & CE-10** for the above-mentioned works and who are duly endorsed by the Office of Chief Engineer Buildings/PHE GoAJK having validity for FY 2019-20. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Local Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture. Without such approval, bidding document will not be issued.
3. Eligible Bidders after acquiring complete information & inspection of sites may obtain Bidding Documents from the Office of the Employer, at **Office of Executive Engineer PWD, Public Health Engineering Division, Block-I District Headquarter Complex Muzaffarabad AJK Ph. No. 05822-920028.**
4. A complete set of Bidding Documents of any above mentioned package could be purchased by the interested bidder on submission of the following on or before **16th May, 2020** during the office hours;
- a) Payment of a non-refundable tender fee of **Rs. 3500/-** per Package.
5. The security for a bid submitted by a joint venture should be in the name of the JV. All CDRs/Bank Guarantees except successful bidder will be released after the verification from the relevant bank and as per procedure laid down in the bidding documents.
6. Bidding documents will be issued only to Contractor(s)/Firm(s) or their permanent employer(s) who will submit original power of attorney along with original authority letter on stamp paper of Rs. 100 with each page attested by the Oath Commissioner.
7. Bidding will be done on "AJKCSR 1st Semi-annual (Jul. to Dec. 2019) FY 2019-20, District Muzaffarabad, above/below" basis. Contractor has to write his bid in tender form both in words and in digits and only two digits after decimal will be considered.
8. Only eligible Firms/Bidders, with the following qualification, can participate in the bidding process:

- a) has completed at least one (01) contract of similar nature of work during the last five (5) years, with at least value of PKR 40.000 million for package I , PKR 45.000 million for package II & PKR35.000 million for package III respectively.
9. Bid must be delivered to **Office of Executive Engineer PWD, Public Health Engineering Division Muzaffarabad, Block-I District Headquarter Complex Muzaffarabad AJK** at or before **11:00 AM**, on **19th May, 2020**. Bids will be opened at **11:30 AM** on the same day, in the presence of Bidders or their Permanent Employer who choose to attend at the same address.
10. In case the bidders quoted their rates equal to 10% or more than 10% below the Engineering Estimate, they shall have to provide additional bid security along with their bid in the shape of CDR or Bank Guarantee from any scheduled bank in Pakistan having its branches in Azad Kashmir, equal to the amount of difference between the estimated and bid costs. Failure to do so will result in non-responsiveness.
11. All bidders must fill in check list as a mandatory task before submission of their bid in their own interest as per section "G" of Instructions to Bidders (I.B).
12. Any bid prepared and submitted in contrary to sections C&D respectively of Bidding Documents, as mentioned in "Instruction to Bidders" shall be declared as non-responsive.
13. The employer reserves the rights to reject all of the bids or any bid under the Clause 32 of AJK PPRA Rules.
14. No offer shall be considered valid if participating firm/person/contractor is black listed, debarred, suspended or removed from the approved list by any other procuring agencies or by AJK PPRA & is not involved in any litigation with the department. Any conditional, ambiguous, incomplete, supplementary or revised offer after submission of bid shall not be entertained.
