AJK Electricity Department Muzaffarabad invites sealed bids (on open competitive bidding basis single stage one envelop) from WAPDA pre-qualified manufacturers, registered with WAPDA and AJK-ED for supply/recycling of below mentioned stores for financial year 2020-21 (against Normal budget) according to relevant WAPDA specifications (amended to date) as mentioned in the bidding documents. Tenders should reach in this office on or before 11-06-2020 at 11:00 (a.m). Tenders shall be opened on the same day at 11:30 (a.m) in the office of the Chief Engineer Electricity Muzaffarabad (Chairman Departmental Purchase Committee No.1) in the presence of bidders or their authorized representatives who choose to attend the meeting:-

IMPORTANT CONDITIONS:-

1. All store items (material) shall be supplied recycled strictly according to relevant WAPDA specifications (amended to date).
2. Each bid should be supported with a Bid security (in the form of Call Deposit receipt, Demand Draft, Pay Order, valid Bank Guarantee issued from any scheduled bank to be verified) for an amount 2% (Two percent) of the bid value in favour of the Chief Engineer Electricity Muzaffarabad. Validity of Bank guarantee should not be less than 150 days from the date of bid/tender opening.
3. Rates should be quoted exclusive of General Sales Tax on Free Consignee Store (FCS) Muzaffarabad A.K basis.
4. Validity of rates should not be less than 120 days from the date of bid opening.
5. All terms and conditions governing this tender are mentioned in the bidding document (ready for obtaining) which can be obtained on payment of price of Rs.400/- each (cost of printing and providing the document) up to 10-06-2020 during office hours from this office.
6. For Items at S#1 and 4, samples must be provided by the bidders along with the bids at the time of bids opening otherwise, offer shall not be entertained.
7. Income Tax, Tajweed-ul-Quran Trust Fund, Stamps Duty and all other duties/taxes applicable in AJ&K at prevailing rates shall be deducted from the bills of successful bidders at source.
8. Black listed firms/ companies/ suppliers/ distributors/ contractors/ bidders are prohibited for participation. All bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with government anywhere in territory of the state of the AJK, federally administrated areas or Islamic Republic of Pakistan.
9. Evaluation report /award of contract shall also be displayed at AJK PPRA website.
10. The Competent Authority (DPC-I) shall reserve the right to accept or reject all or any bid as per AJK PPRA rules.
