2. A complete set of Bidding Documents may be purchased till July 25, 2020 @ 1500 Hours by an interested bidder on submission of a written application and upon payment of a non-refundable fee of Rs. 5000/- for S.No 01 & Rs. 3000/- for S.No 02 & 03 from the **office of the undersigned**.
3. Bids will be issued only to eligible bidders or their representatives upon furnishing of application along with power of attorney/Authority Letter from the bidder.
4. Bidding documents will be issued only to Contractor (s) / Firms (s) or their representative (s) having Original license by the Pakistan Engineering Council in the category C-5 and above with specialization code CE-10 for S.No 01 & C-6 or Above with specialization code CE-10 for S.No 02 & C-6 or Above with specialization code CE-09 -10 for the above mentioned work and should be duly endorsed by the **Office of Chief Engineer Building/PHE (north) GoAJK** having validity for FY 2019-20, who will submit original power of attorney along with original authority letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
5. All bids must be delivered to the **Committee Room Block-N District Headquarter Complex Muzaffarabad AJK** at or before 12:00 AM, on July 27, 2020. The Bids will be opened at 1230 hours on same day, in the presence of bidder's representatives who choose to attend at the same address. Only the responsive bids will be considered. Bids received through Postal Services will not be entertained. Conditional, incomplete & bids filled with Led pencil will not be acceptable.

6. Bidding will be done on "AJK CSR 1st Semi annual Jul-dec 2019 FY 2019-20 District Muzaffarabad above/below basis". Contractor has to write his bid in tender form both in words and in digits and only two digits after decimal will be considered
7. All interested bidders must bring their original PEC registrations at the time of bid opening. Failure to do so will result in non-responsiveness
8. In case the bidders quoted their rates equal to 10% or more than 10% below than Engineering Estimate, will have to provide additional bid security along with their bid in the shape of CDR or Bank Guarantee from any scheduled Bank of Pakistan/AJK equal to the amount of difference between the estimate and bid costs. Failure to do so will result in non-responsiveness.
9. Each bidder shall sign each page of bid documents especially Form of Bid, failure to do so shall result in non-responsiveness.
10. The competent authority reserves the right to reject all the bids or any bid under the clause 33 of AJK PPRA Rules.


