- 4- Interested firms should quote their rates on Delivered Duty Paid basis at Rawalakot , AJK i.e. inclusive of all applicable taxes, transportation and all other charges
- 5- Each financial bid must be accompanied by the acceptable CDR/bank draft not less than 2% of the bid value drawn on any schedule bank in favor of Executive Engineer Building Division Rawalakot.
- 6- Incomplete or conditional bids shall not be entertained
