TENDER NOTICE

ELECTRICAL WORK & HISTORICAL ILLUMINATION OF RED FORT, MUZAFFARABAD

The AJ&K Tourism & Archaeology Department (the "Employer") invites (through WCLA) sealed tenders from the Pakistan Engineering Council registered contractors in at least C-5 category having relevant experience in illumination of historic/heritage buildings/ monuments for electrical work & historical illumination of Red Fort, Muzaffarabad. The execution as per Govt. approved agreement regarding processing of all tendering is the responsibility of Walled City Lahore Authority (WCLA), Lahore.

Terms & Conditions:

1. Under AJKPPRA rules "Single Stage Two Envelop Procedure" (separately sealed Technical & Financial) procedure shall be adopted and Least cost selection method will be applied.
2. Interested bidders may obtain the Bidding Document comprising of detailed information, general and technical specifications about electrical work & historical illumination of Red Fort, Muzaffarabad, from office of the Director Conservation/ Planning, Walled City Lahore Authority (WCLA), 54 Lawrence Road, Lahore against the payment of Rs. 1000/- (non-refundable) from 3rd - 13th August, 2020 (during office hours).
3. Bidders shall submit the CDR as bid security (Which is well within 5% of the quoted cost) in the name of the Director General, AJ&K Tourism & Archaeology Department, Muzaffarabad in the sealed Financial Tender;
4. The bidding document must reach at the Office of the Director Conservation/ Planning, Walled City Lahore Authority (WCLA), 54 Lawrence Road, Lahore on or before 20th August, 2020 at 1030 hrs. The bids will be opened in presence of the bidders or their authorized representatives and committee members on the same date and same address at 1100 hrs.
5. No tender will be issued after closing time in any circumstances and no tender will be accepted after fixed time. Conditional and telephonic tenders will not be entertained.
6. Bid Validity period for each of the bidders is 90 days.
7. No tender will be accepted after fixed date and time as well as conditional and telephonic tenders will not be entertained.
8. The competent authority (Chairman Committee) may cancel any or all tenders as per AJ&K PPRA Rules, 2017.
