- A foreign bidder is entitled to participate in the bidding only if having a Joint Venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws.
- Interested bidders desirous to bid as joint venture must get prior approval of his joint venture from the employer/Chief Engineer Building/PHE (North) Muzaffarabad Azad Jammu & Kashmir. Bidding documents will not be issued without such approval.
- 5. A complete set of biddings documents will be issued to eligible bidders having following qualification.
- a) Firm/Contractor has completed atleast one contract of similar nature of work with the minimum value of PKR: 521.919 Million within last 3 years.
- b) Firm/Contractor has an Average Annual Turnover of PKR 372.800 Million for last 3 years.

 - a) Readable/Attested Audit Reports of the firm for last three (03) Fiscal years duly prepared & vetted by Chartered Accounted firm registered with ICAP Pakistan.

Bidders quoting rates equal to 10% or more than 10% below than the Engineer's Estimate will have to provide additional performance security along with their Financial bid in the shape of CDR or Bank Guarantee from any Scheduled Bank of Pakistan/AJK equal to the amount of difference between the estimated cost and quoted bid cost. Failure to do so will result in non-responsiveness.
 - Pre bid meeting will be held in the office of the Superintending Engineer PWD Building /PHED Circle Rawalakot on 24 September 2020 at 1100 Hrs.
 - 11. The Bidders are required to submit their Financial & Technical bids (sealed) in separate envelopes (one original and two copies), clearly marked as ORGINAL and Duplicate in a single envelope before 1130Hrs on 5-10-2020. Technical bid will be opened by the bid opening committee at 1200Hrs on the same day in office of the Superintending Engineer PWD Building /PHED Circle Rawalakot in the presence of bidders or their representative who choose to attend at the same address. After scrutiny and evaluation of the technical bids, the financial bids of only qualified bidders will be opened for which a separate date will be fixed and will be intimated to all qualified bidders in writing, by the office of the Executive Engineer PWD Building Division Rawalakot. Financial bids of unsuccessful bidders will be returned un-opened.
 - 12. Conditional, incomplete and bid filled with led pencil will not be acceptable.
