Invitation for Bids

Sealed bids are invited for procurement of Bulk Medicines/Vaccines, X- Rays films, Surgical, Disposables, Sutures, Dental Material, Dressing Material, Dialysis Material and Lab Chemicals/ Kits and PPE'S for Health institutions & hospitals of AJ&K Health Department during the financial year 2020-21, which will be received up to at 11:00 am dated 14.10.2020 in the office chamber of the Secretary Health, GoAJ&K Block No. 10, New Secretariat, Chatter, Muzaffarabad and will be opened on the same day at 11:30 am in the presence of bidders or their authorized representatives who choose to attend the meeting of bid opening.

1. Bidding shall be conducted through Single Stage - Two Envelopes bidding procedure of AJK Public Procurement Rules, 2017. The envelopes shall be marked as **“TECHNICAL PROPOSAL”** and **“FINANCIAL PROPOSAL”** in bold and legible letters. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective bidder.
2. For supply of pharmaceuticals /vaccines, surgical disposables, surgical sutures, dental materials, dressing materials, dialysis material, X-Ray films & chemicals and Lab Chemicals/Kits and PPE'S for Covid-19 and Swine Flu, all Manufactures/ Authorized Importers and Authorized Distributors can participate according to technical criteria mentioned in the bidding document.
3. Bid Security (CDR) @ 3% of total bid value of quoted items in the name of Director General Health AJK Muzaffarabad must be accompanied with the financial bid. Cheques shall not be accepted.
4. Bids shall remain valid for 120 days.
5. A complete set of Bidding document including detail specifications, quantity, terms & conditions and evaluation criteria can be obtained up to 13.10.2020 on or before 04:00pm on submission of written application on letter pad and upon payment of Rs. 1000/- (Rupees One thousand) (Non-refundable) in shape of cash or bank draft as bidding document fee from Director Health Services (Ph.#05822-920014) Email. dghstore206@gmail.com from the office of the Director General Health AJK New District Headquarter Complex Room No.31, 1st Floor, Block **“F”** Muzaffarabad.
6. All taxes/ duties levied by GoAJ&K will be charged from the bills under admissible rules.
7. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents are mandatory.
8. All bidders shall furnish an affidavit /certificate that they are neither black listed nor in conflict with government anywhere in territory of the State of Azad Jammu & Kashmir, Federally administrated areas and provinces of Islamic Republic of Pakistan.
9. All bidders (Companies, Firms, Distributors, Dealers) are directed to make registration with AJ&K Income Tax Department otherwise, they will be considered as Non Filer in AJ&K.
10. Evaluation Report and Award of Contract shall also be displayed on PPRA web site (www.ajkppra.gov.pk).
