The Executive Engineer (Secretary Works Committee), Women University of Azad Jammu and Kashmir, Bagh on behalf of the Employer invites sealed bids in accordance with AJK PPRA Rules 36(a) **Single Stage-One Envelope** bidding procedure from the eligible firms/ contractors licensed by the Pakistan Engineering Council in appropriate category mentioned against work in column 3 below **with Specialization Code CE-10** for the following work.

2. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the **Office of the Executive Engineer (Secretary Works Committee) Women University of Azad Jammu and Kashmir, Bagh, Ph. No. 05823-960054.**
3. A complete set of Bidding Documents may be purchased by an interested bidder on submission of the following.
- Submission of a written application to the Executive Engineer Women University of Azad Jammu and Kashmir, Bagh, AJ&K.
  - The cost of bidding documents (non-refundable) shall be charged amounting to PKR. 1500/- as tender fee plus prevailing Taxes.
  - Original Power of Attorney along with original Authority Letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
  - Original PEC License must be presented at the time of purchase of bidding documents.
  - A declaration /Affidavit that he or its firm is not blacklisted by any department of AJK / Pakistan and is not involved in any litigation with any Government Department.
4. All bids must be accompanied by a Bid Security of amount mentioned in column 4 above.
5. The bid securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of validity of Bid Security whichever is earlier.
6. Bidding will be done on "AJKCSR 1<sup>st</sup> Semi-annual (July to December 2020), District Bagh, on percentage (above/below) basis. Contractor has to quote the rates of Bid price in words and in figure and only two digits after decimal will be considered. The condition of two figures after decimal point will also apply in case of quoted rates.
7. In case the amount of bid offered is less than the estimated cost by 10% or more than 10%, the bidder shall provide with the bid additional bid security in the shape of CDR/ Bank Guarantee issued by a Schedule Bank in Pakistan or Bank of AJK, equal to the

amount of difference between the Estimated Cost and the Bid Cost. Failure to provide the said additional Bid security with the bid, the bid shall be considered as non-responsive and rejected.

8. Conditional, incomplete, unsigned and bids filled with led pencil will not be acceptable.
9. The selected firms/ Contractors shall pay all taxes, etc prevailed in AJK.
10. Bid through courier / Fax shall not be acceptable.
11. Bids will be opened by the bid opening & evaluation committee in the presence of Bidders or their representatives who choose to attend at the following address.
