All bids must be accompanied by a bid security in the amount of 2% of quoted bid price and must be delivered to office of the Executive Engineer Building Division Haveli at or before 11:00 Hours on 19-10-2020. Bids will be open 12:00 hours on the same day in the presence of bidder's representative who may choose to attend at the same address.

3. The bidding procedure will be "Single stage, Two envelope" the bids shall be submitted by the interested firms in two separate envelops marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in legible and bold letter. The technical proposals shall be opened on the day of bids opening and financial proposals shall be kept sealed in custody till final evaluation of the technical proposals. The financial proposal of technically responsive bidders shall be opened on the notified date and time, in the presence of the representatives of the qualified/responsive firms.

4. All taxes/funds will be deducted according to the prevailing AJ&K Government rules.

Firms registered as furniture manufacturer, Electronics, Bedding, Clothing and Crockery supplier with GST and income tax Department GOP/GoAJ&K only shall be eligible for the supply of items.

6. Firms must have their own work shop, wood seasoning plant and authorization of dealership for supply of furniture

7. Incomplete or conditional bids shall not be entertained.

8. A complete set of detailed documents of above work may be purchased by an interested bidder on submission of a written application with original documents to the office of Executive Engineer Building Division Haveli (Kahutta) upon payment of non-refundable fee.

9. In case of the bidder quoted their rates equal to 10% or more than 10% below than engineering estimate, will have to provide additional bid security along with their bid in the shape of CDR issued by a Schedule Bank in Pakistan having its branches in Azad Kashmir, equal to the amount of difference between the Engineering Estimated and the Bid Cost. Failure to provide the said additional bid security with the bid, the bid shall be considered as non-responsive and rejected.
