EXPRESSION OF INTEREST (REQUEST FOR PROPOSAL) Single Stage Two Envelope Procedure

The Azad Government of the State of Jammu & Kashmir through the **Chief Engineer (PP&H) Building/Public Health Engineering (North) Muzaffarabad** intends to hire consultancy services /firms for resident supervision services for projects: Construction of Makri Intake Weir & Installation of Flow Metering System & Geo Technical Investigation for Makri Intake Muzaffarabad.. Technical & Financial Proposal are requested for consultancy services from the consultancy firms registered with Pakistan Engineering Council (PEC) having adequate experience of performance on similar works along with qualified technical personnel. Request for Proposal (RFP) may be purchased from the office of **Executive Engineer, PWD Public Health Engineering Division, Muzaffarabad, from 20th October, 2020** during office hours by interested eligible consultancy firms on submission of application along with copy of PEC Registration and upon payment of non-refundable fee of rupees three thousand five hundred only (PKR 3500/-).

The pre-proposal meeting is scheduled on **21st October, 2020 at 11:00am** in the office of the **Superintending Engineer, PWD PHE Circle, Muzaffarabad.**


The deadline for submission of technical and financial proposals is **23rd October, 2020** at, or before **11:00am**. The proposals will be opened on the same day at **11:30am** in the presence of the consultants or their representatives who choose to attend the meeting in the Office of the **Executive Engineer, PWD Public Health Engineering Division, Muzaffarabad.**

The selection process will be Single Stage Two Envelope & “Quality Cum Cost Based Selection” (QCBS).

The consultant should send their proposals by courier or by hand in separate sealed envelopes clearly marked as “Technical Proposal” and “Financial Proposal” keeping both in one sealed envelope to above mentioned address. The bid security @ 2.5% of the bid price will have to be furnished in a sealed envelope enclosed in the Technical Proposal envelope & marked clearly as “**BID SECURITY**”. In case of any discrepancy in the bid security, the Technical Proposal will be consider as non-responsive.


Proposal received after deadline of submission of bids will not be entertained.
