1. The **Government of AJ&K(The Employer)** has allocated funds through development Budget for execution of the following projects through ADP 2020-21 and it is intended that part of the proceeds of the credit will be applied to eligible payments under the Contract for the following work;

Bidding is open to all eligible Bidders.

- Bidding documents can be purchased from undersigned's office on submission of a written application to the Executive Engineer PWD Building Division Bhimber along with CDR amounting 3% of Estimated Cost as mentioned in column No.3. The CDR must be issued by a scheduled Bank of Pakistan, having its branch in Azad Jammu & Kashmir in favour of the Employer as earnest money and upon payment of non refundable tender fee, as mentioned in column No.6 on or before **26-10-2020** during office hours. The application must be accomplished by a declaration/Affidavit that the applicant or his firm is not blacklisted by any of the department/ministries. Bidding documents will not be issued without this declaration.
- The application must be accompanied by a declaration/Affidavit that he or his firm is not blacklisted by any department of AJk /Pakistan.
- Bidding documents will be issued only to the constructor/Firm or their authorized representatives who will show the original power of attorney along with original authority letter.
- The bidders are required to submit their bid at 11:30 AM on 27 October, 2020 in the office of undersigned. Bids will be opened by the bid opening committee at 12:00 Hrs on the same day in the presence of bidders or their representatives who choose to attend. Incomplete and bid quoted with led pencil will be rejected.
- The bidder should quote his rate in percentage above /below or at par of "**AJK CSR 1st Quarter (July-Sept.) 2020-21, District Bhimber** for schedule items and item rate for none schedule items. For none schedule items bidder has to quote his rate in figures, limiting up to two decimal points. (Figures after two decimal points shall not be considered).
- In case the amount of bid offered is equal to 10% or more than 10% below of the estimated cost, the bidders shall have to provide additional performance security in the shape of CDR issued by a schedule bank of Pakistan, having its branches in Azad Jammu & Kashmir, equal to the amount of difference between the estimated cost and bid cost. Failure to provide the said additional performance security with the bid will make the bid non-responsive and will be rejected.

8. All CDRs except successful bidders will not be released before the due verification. No CDR will be released on the bidding day.
9. The Competent authority in accordance with PPRA Rule -33 reserves the right to reject all Bids or proposal at any time prior to the acceptance of bid or proposal.
