 - b) Original Power of Attorney along with original Authority Letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
 - c) Original PEC License must be presented at the time of purchase of bidding documents.
- iii. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws duly registered, approved and endorsed by the Employer.
- iv. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.
- v. The bid securities of unsuccessful bidders will be returned as per criterion mentioned "**Instruction To Bidders**" of the bidding documents.
- vi. Bidding will be done on "AJKCSR 1st Semi-annual (Jul. to Sept. 2020) FY 2020-21, District Muzaffarabad, on percentage (above/below) basis. Contractor has to Quote the rates of Bid price in words and in digits and only two digits after decimal will be considered.
