**INVITATION FOR BIDS (IFB)**

Local Government & Rural Development Department, Go AJK has received a fund from WAPDA for the execution of "Integrated Solid Waste Management & Recycling (ISWM&R)" project in Municipal Corporation Muzaffarabad, to mitigate the negative environmental impacts of NeelumJehlum Hydro Electric Power Project (NJHEP) in Muzaffarabad. It is intended that part of proceed of the credit will be applied to eligible payment under the contract "Construction of Building, Fabrication, Supply, Installation and Commissioning of Material Recovery Facility (MRF) & Composting plant for the Solid Waste of Muzaffarabad city along with allied Collection, Transportation and Management work" on turnkey basis including 2 years O&M period.

- i. Proposal /bids (both technical & financial) are invited from interested firm/companies/contractor/joint venture having sound experience in the handling of Municipal Solid Waste Management and registered in Pakistan Engineering Council in relevant code and category in C-4 or above.
- ii. The bidding shall be under single stage two envelopes (containing two separate envelopes) procedure of AJK, PPRA rules. Each envelope shall contain separately the financial proposal and the technical proposal, the envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion. Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened; the envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the procuring agency without being opened. Financial Bids will be opened later, the date of which will be communicated to the successor bidder of technical bids only. Financial bid of non-qualified bidders will be return unopened after evaluation of the Technical Bids.
- iii. The interested and eligible bidders can obtain Bidding Documents on submission of written application against payment of Rs. 3000 (nonrefundable) and other information in this regard from the Employer office during hours before 28-12-2020.
- iv. All interested bidders are advised in their own interest to carry out a comprehensive on ground survey of project site/ work to be executed, review Muzaffarabad Municipal "Waste Characterization Study" and accordingly submit well informed technical proposal with practical strategy in order to minimize the complication during implementation stage. Employer will not be responsible for any cost or expenses incurred on survey or field visit.
- v. Venue for bid receiving / opening will be Committee Room of Kashmir House Sector F/5 Islamabad.
- vi. All bids must be accompanied by a Bid Security equal to 3% of the bid price in the favour of "Project Director ISWM&R Project Municipal Corporation Mzd" in shape of Pay Order or Bank Draft from any scheduled Bank of Pakistan.
- vii. All bids must be delivered at Committee Room of Kashmir House Sector F/5 Islamabad before 12:00 pm on or before 29-12-2020. Bids will be opened on same day at 12:30 pm in the presence of bidder's representatives who choose to attend at the same address.
- viii. Black listed Firms/Companies/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with any Government department anywhere in territory of the State of AJK,
