



"Azad Jammu & Kashmir Electricity Department" (AJKED) invites sealed proposals/Bids for the supply, installation, implementation and maintenance of "Customized ERP (Enterprise Resource Management System)" from experienced Software Houses and IT companies based in Pakistan and registered with Federal Board of Revenue for Income Tax and Sales Tax and who are on Active Taxpayers List (Income and Sales tax) of the Federal Board of Revenue.

Terms & Conditions:

01. Bidders must provide verifiable documentary evidence for deployments of similar software.
02. Bidders should be registered with Pakistan Software Export Board (PSEB) and must provide its valid Registration Certificate.
03. The Company/Firm shall provide response/support for software (after sale services) for the period of One Year.
04. The Company/Firm should have office/Support Centre in Isb-Rwp/Lahore.
05. Bidding shall be carried out on "Single Stage Two Envelope Bidding Procedure". The Bidding Procedure defined in AJK PPRA Rules 2017 shall be strictly followed.
06. All bids must be accompanied by a Bid Security of at least 5% of Quoted Amount in shape of CDR/Bank Draft/Pay Order issued by a scheduled bank of Pakistan (having at least One branch in AJK), in favor of Chief Engineer (Grid/Construction/Procurement) AJK Electricity Department, Muzaffarabad, valid for 120 days from the date of opening of the bids.
07. Offered rates should be valid for a period of 120 days from the date of opening of the Bids.
08. Offered rates should be quoted inclusive of all taxes & duties applicable in AJ&K excluding GST.
09. Income Tax, Tajweed-ul-Quran Tax, Education Cess, KLC and all other applicable taxes including General Sales Tax (if Applicable) shall be deducted from the invoice(s) of the successful bidder.
10. Interested eligible bidders may obtain further information and purchase complete set of bidding document from the office of the undersigned during office hours from 27 Jan, 2021 to 10 Feb, 2021 on submission of written application and payment of non-refundable fee of Rs. 1,000/- per set of bidding document.
11. The bids prepared in accordance with the instructions of the bidding document must reach at the office of the undersigned on or before 11:00AM on 11 Feb, 2021. Bids will be opened on the same day at 11:30AM in presence of Bidders' representative(s) who choose to attend.
