- i) Purchase of "Chinese Hybrid Silkworm Eggs Packets (Imported)" against approved Development Scheme of Sericulture Department, "FARMERS TRAINING AND DEMONSTRATION OF PRODUCTS OF SERICULTURE DEPARTMENT IN AJ&K", on FOR basis at Sericulture Center Afzulpur District Mirpur, Chack Dhamni District Rawalakot and Directorate of Sericulture Muzaffarabad.
- ii) A complete set of detailed documents of above work may be obtained by interested / eligible bidders on submission of a written application with payment of Rs. 200/-.
