- All bids must be accompanied by a Bid Security @ 3% of the total value of the bid in shape of Pay Order/Demand Draft/Call Deposit in the favor of DDO Account no. 1840-1, NBP main branch Muzaffarabad, Azad Jammu & Kashmir Public Service Commission. The Tender without 3% Bid Security shall not be considered; cheque shall not be entertained;
- The bidding shall be conducted through Single Stage--Two Envelop Procedure of AJK-Public Procurement Rules, 2017. The envelops shall be marked as 'Financial Proposal' and 'Technical Proposal' in bold and legible letters along with list of organizations/departments to which similar equipment has been supplied in the past and certificates of 'Satisfactory Service' from such organizations. Financial proposal of the bids found technically non-responsive shall be returned un-opened to the respective bidders;
