The Executive Engineer Grids/Transmission Lines AJK Electricity Department (AJKED), invites sealed Bids in accordance with AJK PPRA Rule 36(a) Single Stage One Envelope bidding procedure from eligible Contractor(s)/Firms(s) for the following Works:

#### ELIGIBILITY CONDITIONS:

1. The Bidding Document will be issued to those eligible bidders only who meets the following Qualification Criteria and provide the relevant verifiable documents.
  - a. The Bidder should have a valid PEC Registration Certificate, having Specialization Code CE-10 (original PEC License must be presented at the time of purchasing bidding documents).
  - b. The Bidder should be registered with income tax department and must be on active tax payer list.
2. The Bidding Document will be issued to the eligible Bidders after the submission of written application along with the Authority letter (on company letter head) to the undersigned and upon payment of a non-refundable fee of Rs. 500/- per set of the Bidding Document from Office of undersigned from 16March, 2021 to 30 March, 2021 during office hours.
3. The Bids shall be valid for a period of 120 days from the date of opening of Bids.
4. Bid Security @5% of the total quoted Bid Price in the form of CDR issued by a Scheduled Bank of Pakistan having at least one branch in AJK in favor of Executive Engineer Grids/Transmission Lines Division Rawalakot, AJK Electricity Department, valid for the period of 120 days must be submitted with the proposal.
5. Rates should be quoted inclusive of all applicable Taxes, Duties applicable in AJK i.e. Income Tax, Tajweed-ul-Quran Tax, Education Cess, KLC.
6. All the taxes applicable in AJK should be deducted from the invoices of the successful bidder.
7. Bids prepared in accordance with the instructions of the Bidding Document must reach at the address below on or before 10:00AM on 31 March, 2021. The Bids will be opened on the same day at 10:35AM, in the presence of bidders or their authorized representatives who choose to attend.
8. Any bid prepared and submitted in contrary to the Terms & Conditions of the bidding document shall be declared as non-responsive.
