2. Rates of Items and Services should be provided **per unit and in total also** in PKR.
3. Bidding shall be conducted through Single Stage- two envelopes procedure of AJ&K PPRA rules 2017. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters. Financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.
4. Bid security (Call Deposit Receipt) @3% of total bid value in the name of Director Food AJ&K must be accompanied with the bid, Cheques shall not be accepted.
5. All taxes/duties levied by GoAJ&K will be deducted from the bills under admissible rules.
6. All bids should be submitted in Tape Binding. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each paper of bidding document/form is mandatory.
7. A certificate must be attached with the bid that the firm is not blacklisted or debarred from any government or its organization or project.
