


- Engineering Council (PEC) and duly endorsed by Chief Engineer Highways (South) Public Works Department AJK renewed for the **Year 2020-21** in the appropriate category with field of specialization.
2. A complete set of bidding documents may be purchased by an eligible bidder on submission of a written application to the office of **EXECUTIVE ENGINEER PWD Highways Division Kotli** along with "**Bid Security**" issued by a Schedule Bank of Pakistan having its branches in Azad Kashmir in favor of **EXECUTIVE ENGINEER PWD Highways Division Kotli** as mentioned in column **No.9** and upon payment of a non-refundable tender fee mentioned in column **No.7** on or up to **28-04-2021** during office hours. The application must be accompanied by a declaration/affidavit that he or its firm is not black listed by any of the departments/ministries and it must also state the names of the works with costs, if any, allotted to him which are still under execution. Bidding documents will not be issued without this declaration/affidavit.
 3. The bidder should quote rates in "**Percentage above/below on the basis of AJK CSR Up-dated for 1st Quarter (Jul-Sept.) 2020-21**" and write his rates in figures, limiting to two figures only after decimal point (any figure beyond two figures after decimal point shall not be considered). The condition of two figures after decimal point will also apply in case of quoted rates.
 4. Tender Documents will be issued only to constructor(s)/firm(s) or their authorized representative(s) who will show original power of attorney along with original Authority Letter clearly mentioning the work for which authority letter is issued.
 5. All bid securities of unsuccessful bidders will be released after the verification from bank and as per procedure laid down in the bidding documents. The bid security of successful bidders will be returned when the bidder has furnished the require performance, Guarantee.
 6. All Bids must be delivered at the office of **EXECUTIVE ENGINEER PWD Highways Division Kotli Near Shaheed Chowk** on date **29-04-2021** at **01:00 P.M.** Bids will be opened on same Date at **01:30 P.M.** by the bid opening committee in the presence of bidder(s) or their representative(s) who chose to attend. Conditional, incomplete and bids filled with led pencil will not be acceptable. Any bid if not accompanied by an acceptable **Bid Security** shall be rejected by the employer as non-responsive. The selector firm / Contractor(s) shall pay all Taxes levied in AJK.
 7. Bid through Courier / Fax shall not be acceptable.
 8. The Competent Authority reserves the rights to accept or reject all bids or any bid under clause No.33 of AJK PPRA Rules 2017.
