The Executive Engineer PWD Highways Division Muzaffarabad on behalf of the Employer invites sealed bids in accordance within AJK PPRA Rules 36(b) Single Stage-Single Envelope bidding procedure from the eligible firms/contractors/persons licensed by the Pakistan Engineering Council for the following works. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.

- ii. The Purchaser invites sealed bids, under Single Stage-One Envelope bidding procedure, from eligible firms or persons as defined under clause IB-3 of Instructions to Bidders. The bidding is open to National/International Competition as per policy of the government
- iii. All bids must be accompanied by a Bid Security in the amount of Rs. 4,360,000/- (Rupees Four Million, Three Hundred Sixty Thousand Only) or an equivalent amount in a freely convertible currency in the format of bank guarantee on bid security form provided or in the form of deposit at call or from a foreign bank duly counter guaranteed by a Scheduled Bank in Pakistan in favour of Purchaser and must be delivered to **Office of the Executive Engineer PWD Highways Division, 2nd Floor Block – I, DHQ Complex Muzaffarabad** at or before **12:30 hours**, on **3rd May 2021**. Bids will be opened at 1300 hours on the same day, in the presence of Bidder's representatives who choose to attend at the same address
- iv. A complete set of Bidding Documents may be purchased by an interested bidder on Submission of the following.
 - a) The cost of bidding documents shall be charged Rs. 6500/- as tender fee plus prevailing Taxes.
 - b) Original Power of Attorney along with original Authority Letter on stamp paper of Rs.100/- with each page attested by the Oath Commissioner. (in case of Authority)
 - c) Original PEC License for the year 2020-21 must be presented at the time of purchase of bidding documents.
 - d) Current litigation information on stamp paper. (Attested)
 - e) Valid Registration with PEC.
 - f) Firm duly endorsed in office of the Employer.

- v. The bid securities shall be, at the option of the bidder, in the form of Deposit at call or Bank Guarantee issued by a Scheduled Bank in Pakistan & Bank of AJK clearly mentioning the name of bidder from his own account in favour of the Employer/ Executive Engineer PWD Highways Division Muzaffarabad valid for a period 28 days beyond the Bid Validity date.
- vi. The bid securities of unsuccessful bidders will be returned upon award of contract to the Successful bidder or on the expiry of validity of Bid Security whichever is earlier.
- vii. Bids will be opened by the bid opening & evaluation committee in the presence of Bidders or their Representatives who choose to attend the following address. Bids received through Postal Services will not be entertained. Conditional, incomplete/Blanks and bids filled with led pencil will not be acceptable.
