- 4 A complete set of bidding documents can be obtained up to **05 May 2021 at 11:00 am** on submission of written application and up on payment of rupees 1000 (non refundable) in the shape of cash or bank draft as bidding document fee from store section of DHQ Hospital Pallandri.
- 5 All bidder shall furnish an affidavit / certificate that they are neither black listed nor in conflict with Govt. anywhere in territory of the state of Azad Jammu and Kashmir , federally administered areas and provinces of Islamic republic of Pakistan.

- 7 All bidders are directed to make registration with AJ&K Income Tax department otherwise they will be considered as non filer in AJ&K.
