LG&RDD intends to install 10 Nos publicity boards at entry point of each district head quarter against the operational budget of financial year 2020-21.

  Envelope procedure" as specified in clause 36(a) of AJ&K Public Procurement Rules 2017
  from the reputed Contractors/Painters/Suppliers at least three years experience of manufacturing
  and erection of small to large size publicity board of both public and private sector in AJK
  subject to the fulfilment of conditions mentioned in Bidding Documents.
- 2. The bidders must be registered with income tax department with active status on ATL of CBR, NTN and Sales Tax registration certificate must be provided by the bidders.
- 3. The bidders are requested to give their best and final prices as no negotiations is allowed.
- The bid must be accompanied by the bid security @2% of quoted price in the form of CDR or pay order in favour of Director General LG&RDD AJK from Schedule Bank of Pakistan.
