
The Executive Engineer Highways Division Jehlum Valley, on the behalf of the Employer, invites sealed bids for open competitive bidding under the **AJK PPRA Rules 36a (Single Stage-One Envelope Procedure)**, from eligible firms or constructors licensed by the Pakistan Engineering Council (PEC) and duly endorsed by Chief Engineer Highways North/South Public Works Department AJK in the appropriate category with field of specialization.

Bidding is open to all eligible Bidders

- i. The bidders are required to submit their bids in accordance with the clause 29 of the AJK PPRA Rules.
- ii. A complete set of bidding documents may be purchased by an interested bidder on or before **10-05-2021** during the office hours.
- iii. Submission of Bid Security in form of CDR/Bank Guarantee as mentioned in Column No. 4 must be attached with financial proposal. The CDR must be issued in favor of the employer by a schedule Bank in Pakistan having its branches in Azad Kashmir or Bank of AJK.
- iv. The application must be accompanied by a declaration/affidavit that he or its firm is not black listed by any of the departments/ministries. Bidding documents will not be issued without this declaration/affidavit.
- v. Tender Documents will be issued only to constructor(s)/firm(s) or their authorized representative(s) who will show original power of attorney along with original authority letter on stamp paper of Rs.100/-.
- vi. All CDRs except successful bidder will be released after the verification from bank and as per procedure laid down in the bidding documents.
- vii. The bidder should quote rates in "percentage above/below on the basis of AJKCSR" and write his rates in figures, limiting to two figures only after decimal point (any figure beyond two figures after decimal point shall not be considered). The condition of two figures after decimal point will also apply in case of quoted rates.
- viii. Successful Bidder shall furnish to Employer performance security of 10% amount of contract mention in Letter of Acceptance in the form of CDR or Bank Guarantee in favor of Executive Engineer PWD Highways Division Jehlum Valley from Schedule Bank of Pakistan having its Branches in AJK or Bank of AJK within 14 Days issuing of Letter of Acceptance.
- ix. Bid must be delivered at the office of under signed on or before **11-05-2021** at **11:00 A.M.** Bids will be opened on **11-05-2021** at **11:30 A.M** For Serial No. (i) , **12:00 PM** For Serial No. (ii) & **12:30 PM** for Serial No. (iii). by the bid opening committee in the presence of bidder(s) or their representative(s) who chose to attend. Conditional, incomplete and bids filled with led pencil will not be acceptable.
- x. The Employer reserves the rights to reject all of the bids or any bid under the Clause 33 of AJK PPRA Rules.
