

Financial Bids of only technically qualified bidders shall be opened. Financial bids of bidders which may not qualify shall be returned unopened.
- The bid security, 2% of the cost of bid must be submitted with Bid in the form of CDR in the name of Bank of AJK. No tender will be accepted without Bid Security and such tender(s) will be rejected out rightly.
- Incomplete /conditional bid and bid bearing cutting / over writing without authentication will not be considered.
- Bids must be delivered to the address below on or before 20-05-2021 at 11:30 AM.
- Bid-opening will be held on 20-05-2021 at 12:00 PM
- Prices must be quoted inclusive of all taxes.
- Blacklisted firms /Companies/Suppliers/Distributers/Contractors/Bidders are prohibited for participation. All bidders shall furnish an affidavit/certificate that they are neither blacklisted nor in conflict with Government anywhere in territory of the State of the AJK, Federally Administrated Areas or Islamic Republic of Pakistan.
- Evaluation report/award of contract shall also be displayed at AJK PPRA Website.
- Valid NTN/GST Registration Certificates required with the bid.
- The Committee reserves right to accept or reject any or all the bids as per AJK PPRA Rules.
