- 3 Bids security (CDR) @ 3% of total bid value of quoted items in the name of medical superintendent DHQ Hospital Pallandri must be accompanied. Cheques shall not be accepted.
- 4 A complete set of bidding documents can be obtained up to **10 June 2021 at 10:00 am** on submission of written application and up on payment of rupees 1000 (non refundable) in the shape of cash or bank draft as bidding document fee from store section of DHQ Hospital Pallandri.
- 5 All bidder shall furnish an affidavit / certificate that they are neither black listed nor in conflict with Govt. anywhere in territory of the state of Azad Jammu and Kashmir, federally administered areas and provinces of Islamic republic of Pakistan.
- 6 Evaluation report and award of contract shall also be displayed on AJ&K PPRA website.
- 7 All bidders are directed to make registration with AJ&K Income Tax department otherwise they will be considered as non filer in AJ&K.
- 8 All taxes / duties levied by GoAJK will be charged from the bills under admissible rules
- 9 All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking attached in sequence should have signatures of authorized persons. Moreover signing and stamping of each page on bidding documents/forms are mandatory.
