A Foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws. Bidders desirous to bid as Joint Venture must get prior approval of the employer for bidding as joint venture.

 - Original Power of Attorney along with original Authority Letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner, clearly mentioning the work for which authority letter is issued.
 - Original PEC License must be presented at the time of purchase of bidding documents.
- The bid securities of unsuccessful bidders will return upon award of contract to the successful bidder or on the expiry of validity of Bid, Whichever is earlier.
- The bidder should quote rates in "Percentage above/below on the basis of AJK CSR Up-dated for CSR 2009 2nd Semi Annual (Jan-Jun) 2013-14/ CSR Up-dated for 1st Quarter (Jul-Sept.) 2020-21" and write his rates in figures, limiting to two figures only after decimal point (any figure beyond two figures after decimal point shall not be considered). The condition of two figures after decimal point will also apply in case of quoted rates.
- All bids must be delivered at the "Office of "Executive Engineer PWD Highways Division Kotli A.K. near Shahood Chowk Kotli" on date 19 -06-2021 at 13:00Hrs. Bids will be opened on the same date (Bid of Serial No . 1 will be opened at 13:30 Hrs, Bid of Serial No. 2 will be opened at 13:45 Hrs, Bid of Serial No. 3 will be opened at 14:00 Hrs, Bid of Serial No. 4 will be opened at 14:30 Hrs by the bid opening & evolution committee in the present of Bidders or their representatives who choose to attend. Bids received through postal service will not be considered, Conditional, Incomplete and bids filled with led pencil will not be acceptable.
