- The Executive Engineer PWD Buildings Division Sudhnuti (Pallandri) (The employer) invites sealed bids, under **Single Stage Single Envelope** Bidding Procedure, from eligible firms or Constructor licenced by the Pakistan Engineering Council (PEC) for the year 2020-21 and duly endorsed by the Office of the Chief Engineer Building/PHE North Muzaffarabad Azad Jammu & Kashmir in the appropriate category with field of specialization as mentioned in column No. 4 & 5 for the above work. Any information / further detail can be obtained from the office of the undersigned.
- A complete set of Bidding Documents may be purchased by an eligible bidder for the above on submission of a written application to the Executive Engineer PWD Buildings Division Sudhnuti along with CDR as mentioned in column No.8 issued by schedule Bank of Pakistan, having its branch in Azad Jammu & Kashmir in favor of the Executive Engineer PWD Buildings Division Sudhnuti and upon payment of non-refundable tender fee, as mentioned in column No. 6 till **18-06-2021** during the office hours.
- The application must be accompanied by a declaration /Affidavit that he or its firm is not blacklisted by any department of AJK / Pakistan and is not involved in any litigation with any Government Department. Bidding documents will not be issued without this declaration.
- Tender documents will issued only to the constructor's/Firm's or their authorized representatives who will show original power of attorney along with original authority letter.
- The bidders are required to submit their bid at **1200 hrs on 19-06-2021**, bid will be opened by the bid opening committee at **1230 hrs** on the same day in office of Executive Engineer PWD Building/PHE Division Pallandri, Sudhnuti, in the presence of bidders or their representatives who choose to attend conditionally. Incomplete and bid filled with led pencil will not be acceptable.
- The bidder should quote his rate in percentage above/below on the basis of "AJKCSR 1" quarter (July to September) 2020-21, on Schedule Items and non-schedule item rates must be quoted by contractor/ Firm. Contractor has to write his rates (quoted and above / below) in figures, limiting upto two decimal places only.

The bidders quoting rates equal to 10% or more than 10% below than the Engineer's Estimate will have to provide additional CDR along with their Bid issued from any scheduled Bank of Pakistan / AJK & the Bank of Azad Jammu and Kashmir equal to the amount of difference between the estimated cost and quoted bid cost. Failure to do so will result in non-responsiveness/ disqualification.
8. All CDR's except successful bidders will be released after the due verification and as per procedure laid down in the bidding documents.
