- A Complete set of Bidding documents may be purchased by an eligible bidder on submission of a written application till 21st June 2021 during office hours along the following qualifications/Documents:-
 - a. For Scrial # 1 Firm/Contractor has completed at least One contracts of similar nature (Building Construction work only) with the minimum value of PKR25.75 Million during last 3 years.
 - (Completion Certificates must be attached/Provided).
 For Serial # 2 Firm/Contractor has completed at least One contracts of similar nature (Building Construction work only) with the minimum value of PKR 24.67Milloin during last 3 years.
 (Completion Certificates must be attached/Provided).
 - Original power of attorney along with original authority letter on stamp paper of Rs. 100/- with each page attested by the Sub Registrar/Registration officer.
 - iii. Original PEC Licensed must be presented at the time of purchase of bidding documents.
 - iv. Bidding documents can be purchased from undersigned's office with upon payment of non refundable tender fee, as mentioned in column # 6.
 - Declaration/affidavit that the applicant or his firms is not blacklisted by any of the department / ministries must be provided must be provided. So bidding document will be issued on this declaration
 - vi. All bids must be accompanied by a Bid Security of amount as mentioned in column no.5. According to AJK PPRA Rule Clause
 No.25in shape of CDR issued by a schedule bank in Pakistan in favour of under signed and must be delivered to "The Executive
 Engineer PWD Building Division Mirpur AJ&K" before 12:00 hrs on 22-06-2021.

Interested bidders desirous to bid as joint venture, The Share of Principle applicant both in technical & financially will be consider as 70 %& 30 % for cooperative Member during bid Evaluation process .Prior approval of his joint Venture from the employer / Chief Engineer Buildings/ PHE (South) Muzaffarabad Azad Jammu & Kashmir must be provided, Bidding Documents will not be issued without such approval.

- All Call on Deposit (CDR's) except successful bidders will be released after the verification from their concerned banks as per procedure laid down in the bidding documents.
- 5. The bidder must quote rates in percentage above/below basis of AJKCSR 1"Quarter (July to September) 2020-21for District Mirpur and to quote item ratesfor non-schedule/ market items. Only two digits as they appear after decimal point will be considered. Any figures after two decimal points shall not be considered.
- 6. The bidders are required to submit their <u>Original bid</u> (sealed) in single envelope on 22-06-2021 at 12.00 hrs. bids will be opened by the bid opening Committee at 12:30 hrs at the same day in <u>office of the Executive Engineer PP&H Department, Buildings Division Mirpur.</u> in the presence of bidders or their representatives who choose to attend at the same address.
- Conditional, incomplete and bid filled with led pencil will not be acceptable.
- 8. The competent Authority in accordance with PPRA Rule-33 reserves the right to accept or reject any one or all Bids.
