Sealed Tenders under Single Stage- Two Envelope (SSTE) procedure bidding process are hereby invited from all the contractors/ firms, who are registered for current financial year with Pakistan Engineering council (PEC) & endorsed in PP&H, AJK PWD for Financial year 2020-21 in the relevant field & appropriate category. The technical & financial bids must be submitted in separate sealed envelopes in accordance with PEC Guide Lines & AJK PPRA Rules-2017 for the following works.:

Bidding documents can be purchased from undersigned's office on submission or a written application along with Bid Security as mentioned in column No. 5 above. The Bid Security must be issued in shape of Deposit at call by any scheduled Bank of Pakistan/ BAJK, having its branch in Azad Jammu & Kashmir in favor of the Employer and upon payment of non-refundable tender fee. The application must be accompanied by a declaration/ Affidavit that the applicant or his firm is not blacklisted by any of the department/ ministries. Bidding documents will not be issued without this declaration.

Tender documents will be issued only to constructor(s) firm(s) or their authorized representative(s) who will show original power of attorney along with original authority letter.

Interested Bidders desirous to bid as joint venture must get prior approval of his joint Venture from the employer/ Director General Irrigation & Small Dams Muzaffarabad Azad Jammu & Kashmir. Bidding documents will not be issued without such approval.

A complete set of bidding documents will be issued to eligible bidders having following qualifications.

- Firm/ Contractors has Completed at least one contract of similar nature of work during last five years with the minimum value of PKR 50 million.
- Firm/ Contactor has an average Annual turnover of PKR 50 million during last three years.

The bidders must quote rates in percentage above/ below basis of AK CSR and to quote item rates for non-schedule / market items. Only two digits as they appear after decimal point will be considered.

Bidders quoting rate equal to 10% or more than 10% below than the Engineer's Estimate will have to provide additional performance security along with their financial bid in the shape of CDR from any scheduled bank of Pakistan/ BAJK equal to the amount of difference between the estimated cost and quoted bid cost. Failure to do so will result in non-responsiveness. Pre-bid meeting will be held in the office of the Director Irrigation & Small Dams Muaffarabad on 16 August, 2021 at 11:00 AM.

The bidders are required to submit their Financial & Technical Bids (Sealed) in separate envelopes, clearly marked as ORIGINAL and DUPLICATE in a single envelope before 11:30 AM on 24 August, 2021 in Office of Director Irrigation & Small Dams Muzaffarabad and same shall be opened on 12:00 AM in the presence of bidders or their representative. After scrutiny and evaluation of the Technical bids, the Financial bids of only qualified bidders will be opened for which a separate date will be intimated to all qualified bidders in writing, by the office of the Director Irrigation & Small Dams Muzaffarabad. Financial bids of unsuccessful bidders will be returned unopened. Conditional, incomplete and bid filled with lead pencil will be not acceptable.

The undersigned/ employer reserve the right to reject any or all bids without mentioning, the reasons as per clause IB.30 of bidding documents & AJK PPRA Rule 33.
